- I/Legal Guardian do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I/Legal Guardian have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- I/Legal Guardian am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I/Legal Guardian hereby release and agree to hold Zeneith Performing Arts harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of Zeneith Performing Arts, or that may otherwise arise in any way in connection with attending and/or participating in any Zeneith Performing Arts classes.
